



SERVICE AGREEMENT

1. Little Paws Daycare and Boarding agrees to provide day care and/or boarding for the dog(s) ("Dog") set forth in the Little Paws Daycare registration form, and to provide other services as agreed to by and between the Dog owner ("Owner") and Little Paws Day Care & Boarding at the rates agreed upon.
2. Owner may drop of his or her dog for daycare or boarding anytime during our business hours. In the event Owner drops off dog for daycare and cannot or does not pick up dog before closing time,, Owner will pay for overnight boarding care and fees, and may pick up dog the following business day.
3. All dogs over the age of 7 months must be neutered or spayed in order to attend Little Paws Daycare & Boarding, however, Little Paws Daycare & Boarding accepts dogs 7 months or younger that have not yet been neutered or spayed. Little Paws Daycare & Boarding shall not be responsible in the event a female dog becomes pregnant during her stay at Little Paws Daycare & Boarding. Owner represents either that (i) Dog has been neutered or spayed or (ii) Dog is 7 months old or younger.
4. Owner understands and acknowledges that Little Paws Daycare & Boarding has agreed to render services as described herein based upon Owner's representations that: (i) Dog is in all respects healthy and clean and is current on all required and customary vaccinations, including, but not limited to, D.H.L.P.P (Distemper, Leptososis, and Parvo) Bordatella, and Rabies; (ii) Dog has not at anytime in the past harmed or shown aggressive over threatening behavior towards any other person or any other animal; (iii) Dog does not suffer from any disability, illness, or other condition which could have an adverse effect on the health of, or could jeopardize the safety of another dog?
5. Dog may be isolated and kept apart from other dogs should Little Paws Daycare & Boarding determine that the Dog may be in danger or may endanger other dogs by virtue of its conduct or behavior. Owner understands that Little Paws Daycare & Boarding desires to maintain the health reasonable care and comfort of all dogs within its care facility, and to adequately provide for the safe keeping of such dogs in which it has custody.
6. Prior to Little Paws Daycare & Boarding providing any daycare or boarding services, all dogs must pass an initial personality evaluation administered by Little Paws Daycare & Boarding or its appointed representative.
7. It is Owner's responsibility to keep Dog updated on all vaccinations and flea treatments. Owner represents that Dog is currently protected by a flea care preventative and that Dog will be protected by

this preventative throughout each and every day Dog attends Little Paws Daycare & Boarding will administer flea treatment services and Owner will be charged for such services.

8. Owner understands that if a dog remains at Little Paws Daycare & Boarding facilities for a period of 10 days or more beyond the period of time for which an Owner and Little Paws Daycare & Boarding have agreed that Little Paws Daycare & Boarding would provide services for such dog and Little Paws Daycare & Boarding cannot contact Owner, Little Paws Daycare & Boarding will consider the Dog abandoned and Little Paws Daycare & Boarding may place Dog in an appropriate home.

9. The agreement shall be valid for all future use of Little Paws Daycare & Boarding services and Owner agrees that all such reservations and future use of Little Paws Daycare & Boarding services by Dog will be provided by Little Paws Daycare & Boarding pursuant to the terms of this agreement. This agreement may be terminated by either party providing a written notice of termination to the other party.

10. Owner consents to the use of all photographs, videos and photographic images of Dog taken while on Little Paws Daycare & Boarding in any promotional materials of Little Paws Daycare & Boarding, including, but not limited to, publications, advertisements, and Little Paws Daycare & Boarding web-site.

11. Owner recognizes that there is a risk of injury or illness in any environment associated with live animals. Owner recognizes and assumes the risks and danger inherent at Little Paws Daycare & Boarding, dog boarding and dog walking, including, but not limited to, injuries or illnesses resulting from dog fights, rough play, dog contracting fleas, kennel cough, or some other contagious disease, unwanted pregnancies and natural disasters.

12. Owner voluntarily accepts these risks and Owner agrees that the Owner shall remain liable and bear all expenses for any damages that the Dog may cause to any dogs, persons or property, including bites, aggressive behavior, or conduct of the Dog and assumes full responsibility for Dog's action at all times. Owner hereby waives any claim against Little Paws Daycare & Boarding, its owners, agents, employees, directors, and representatives, and to hold harmless the Little Paws Daycare & Boarding Parties and each of them harmless from any liability of any kind whatsoever arising from the attendance and participation of Dog at Little Paws Daycare & Boarding including, without limitation, any and all illness, bodily injury, unwanted pregnancy, death or other damage to Dog or Owner.

Owner agrees to indemnify the Little Paws Daycare & Boarding Parties against all defense costs, including attorneys' fees, resulting from any claim made against the Little Paws Daycare & Boarding Parties, either by Owner or by another party as part of an action against Owner resulting from an action taken by Dog or Owner.

20. In the event Dog becomes ill or injured, Little Paws Daycare & Boarding shall notify Owner, and if Owner cannot be contacted or reached, the emergency contact provided in the Little Paws Daycare & Boarding Form will be contacted. If the emergency contact cannot be reached, Owner has failed to instruct Little Paws Daycare & Boarding regarding measures to be taken, or if an emergency situation exists which requires immediate action, Little Paws Daycare & Boarding is authorized to engage the

service of a veterinarian of Little Paws Daycare & Boarding's choice and to approve medical and/or emergency treatment (excluding euthanasia) as recommended by a veterinarian. Owner therefore hereby allows Little Paws Daycare & Boarding to attain medical attention for Dog from any qualified veterinarian and to transport Dog to and from that veterinarian when Little Paws Daycare & Boarding deems such medical care important for Dog's health. Owner grants Little Paws Daycare & Boarding full power of decision involving the medical treatment of Dog, and authorizes the use of Owner's Card to pay for any such veterinary costs.

14. OWNER REPRESENTS THAT SHE/HE HAS READ THIS AGREEMENT AND UNDERSTANDS AND ACCEPTS THE TERMS AND CONDITIONS STATED.
